

## Senior Managers & Certification Regime

The Senior Managers & Certification Regime (SM&CR) replaced the Approved Persons Regime changing how people working in the insurance sector are regulated.

"The aim of SM&CR is to reduce harm to consumers and strengthen market integrity by creating a system that enables firms and regulators to hold people to account. As part of this, the SM&CR aims to:

- encourage staff to take personal responsibility for their actions
- improve conduct at all levels
- make sure firms and staff clearly understand and can show who does what"

(The Senior Managers and Certification Regime: Guide for FCA solo-regulated firms)

The FCA expects firms to be able to demonstrate how they have embedded in their organisation the processes and cultural change, as required by the regime.

#### For authorised firms already operating under SM&CR we can:

- Carry out an SM&CR audit of your firm's policies, processes and governance structure, assessing if you
  are meeting the requirements under the regime;
